#### 4-11-2008

Mary was **diagnosed** early last year **with stage IV Ovarian Cancer** and only had surgery. She has **refused any other conventional treatments** and has only been doing **4 tsp daily of Poly MVA** for the last year. Her CA-125 was dropping from 30 to 16 but is now going **back up to 32**. So, she has recently **increased her dose of Poly to 8 tsp**.

#### 5-28-2008

Due to the recent elevation in her CA-125 marker, Mary has **started taking 8 tsp of Poly MVA 2 times a day(16 tsp daily)** but it upset her stomach. She has now broken up the dosing into **4 times a day**, at **4 tsp per dose**, and is taking food with each dose.

#### 11-12-2008

Spoke to Mary and she is excited that her CA-125 test has stopped rising and has dropped from 32, back in early April, to 30 a few months ago and is now down to 22 as of November.

#### 9-11-2009

Talked to Mary and **she is doing very well**. She and her husband own a camp ground and have been very busy. Mary will have a **cat scan done at the beginning of October for her six month check up**. She is still taking 8 teaspoon per day.

#### 8-02-2011

Spoke to Mary and she is **doing really well**. She had **tests last month** and **everything came back clean**. She was telling me that NH is fighting to make insurances cover alternative doctors and meds. She said they should know sometime in Sept. if it passed or not.

# 1-31-2013

Spoke to Mary and her **CA-125 markers are still in the normal range**. She thanked me for checking in on her.

Finally talked to Mary again and she is doing wonderful with no problems.
